1 STAFF DIRECTOR DANNENFELSER: Thank
2 you, Mr. Chairman. At this time, I want to
3 provide an update on the status of the building
4 improvements that have been taking place at
5 headquarters. The carpet has been installed in
6 the interior offices throughout the seventh floor,
7 and the public corridors on the seventh floor are
8 in the process of being treated, and they're
9 scheduled for carpeting and painting on Tuesday,
10 September 8th. The contractors on the fifth floor
11 as of Tuesday, September 1st, in Suite 510. All
12 employee offices will be completed, and then the
13 contractor will go to the file rooms, copy rooms,
14 and so on. And that process was actually
15 scheduled to be completed by the end of the day
16 today.

17 The main conference room on the fifth
18 floor is scheduled for work on September 16th.
19 We'll have new shelving for the Commissioner and
20 Staff Director photos installed. Currently, most
21 of the photographs have been sealed to the walls,
22 and we will have those sent out to be reframed.
23 And we also are working on the process of signage
24 relating to the name of the Commission and a seal
25 that will be on the wall of the conference.

1 There's a separate -- a different type of painting
2 and carpeting that will be in the fifth floor
3 conference room than throughout the other parts of
4 the building.

5 The installation of painting and
6 carpeting on the sixth floor is anticipated to
7 take place between September 10th and 14th. And
8 the entire project is expected to be completed by
9 Saturday, September 19th. And we have rented a
10 whole bunch of these heavy duty plastic boxes that
11 people have been using, and we're recycling them
12 as people get in and unload them. And we also
13 have employed the services of some movers to help
14 with some of the heavy duty things that are stored
15 in some closets and file rooms, and also to help
16 some of the staff with some of the heavier objects
17 that they have. But, so far, the process seems to
18 be going pretty smoothly.

7 the National Conference on Civil Rights would be
8 postponed from the originally planned date of
9 October 3rd. The decision was arrived at as a
10 result of conversations that I've had with
11 Commissioner Taylor, aided by Commissioner
12 Kirsanow. They have persuaded me, against my
13 better judgment, that we should revisit the idea
14 of enlisting a Subcommittee to work on the
15 National Conference.

16 This conference is important, and
17 long overdue, and I was quite pleased with the
18 enthusiasm expressed by many of the people that I
19 spoke with. So, in any event, the convening of a
20 Subcommittee at this juncture, in my view, is a
21 step back, but I hope that this suggestion will
22 help us secure meaningful contributions from those
23 Commissioners who felt that they did not have an
24 opportunity to make adequate suggestions in
25 response to the Concept Paper that was circulated.

The same rules should apply to the Subcommittee that applied when I solicited suggestions and edits to my Concept Paper from Commissioners that has every aspect of the conference, from the theme, to content, to suggested speakers would be open to discussion.

That said, a significant amount of thought, time, and effort went into the preparation of the Concept Paper. I would encourage the Subcommittee to use it as a starting point for its deliberation. The date and venue are also up for debate, but I feel strongly that our target date for the conference should not go beyond late March, or, actually, shouldn't go beyond mid-April of 2010. And that we should still hold the event at the National Press Club.

My assistant, Ms. Ludvigson, has contacted the Press Club to assess the availability, and there are still a number of dates open within the time frame that might suit our purposes. It is imperative that the Subcommittee begin its work right away, if we are to nail down a firm date for the event where the venue can accommodate us.

1 The other item that is not open to
2 much debate, I hope, is the budget for the event.

3 The budget should stay around \$100,000. There
4 are savings realized by purchasing certain items
5 this fiscal year that were originally scheduled to
6 be purchased in the next fiscal year. And, also,
7 due to some staff attrition, we can fully support
8 the shifting of the conference to the new fiscal
9 year.

10 So, I move that the Commission
11 appoint a three-person committee consisting of
12 Commissioners Yaki, Kirsanow, and Taylor, to meet
13 over the next two months at intervals they
14 determine via teleconference to make
15 recommendations regarding the National Conference.

16 Under this motion, the Subcommittee is to report
17 on its progress to the Commission during
18 Commission business meetings, and be prepared to
19 present its recommendation to the Full Commission
20 for a vote at an in-person Commission meeting

1 in January of 2008. Commission Staff reached out
2 to the Commissioners, current SAC members, and the
3 Congressional Delegations for the corresponding
4 states, and other officials.

5 I move that the Commission re-charter
6 the Arizona State Advisory Committee. Under this

1 being appointed is a small outreach.

2 CHAIRMAN REYNOLDS: Staff Director?

4 the Staff Director. There was a memo that I sent
5 out to Commissioners in August of 2008, when there
6 were some questions about the process. And I did
7 point to certain instances when the outreach might
8 be more limited, and there were a few examples for
9 Florida, Kentucky, and North Carolina provided at
10 that time, when there was a large number of
11 returning members. In the case of Arizona that
12 we're now considering, even though there were 10

2 Liberties Union of Hawaii thought to invite
3 Clarence Thomas to debate Nadine Strossen, that
4 Ms. Barbee-Wooten said -- made some statements in
5 opposition to inviting Justice Thomas that seem
6 racially offensive. According to the newspaper
7 reports, she wrote first in a letter, I believe,
8 to the organization's First Amendment
9 Subcommittee. She said, "Bringing Clarence Thomas
10 sends a message that the Hawaii's ACLU promotes
11 and honors black Uncle Toms, who turn their backs
12 on civil rights." I think even the inclusion of
13 that term is, at best, racially offensive, the
