Delaware Federal Advisory Committee to the U.S. Commission on Civil Rights Will Examine Implicit Bias and Policing in Communities of Color

Washington, DC – On November 1, 2017, a public briefing meeting of the Delaware Advisory Committee to the United States Commission on Civil Rights (Commission) will examine policing in communities of color in Delaware, including a review of implicit bias.

Committee Chair Lisa Goodman stated, "Policing issues and implicit bias are important topics in the national discussion around criminal justice reform."

The Committee has invited a number of experts who will share their knowledge about these topics and respond to questions from Committee members. The list of expert presenters include academics, advocacy group representatives, community residents and police officers, and police chiefs and other government officials. The agenda, with a complete list of participants, is attached.

Public Comments

Immediately following the panel presentations, the Committee will hear short statements from interested members of the public who wish to share their experiences and knowledge on these topics. The statements will begin at 6:00 pm. Persons wishing to make statements should arrive early. In addition, the Committee will accept written statements through December 1, 2017. Statements should be submitted to the Eastern Regional Office, see below contact information.

Next Steps

There will be a transcript of the day-long meeting and the Committee will submit a written report to the Commission summarizing the results of its examination, including findings and recommendations. The written report will be published on the Commission website at www.usccr.gov—making it available to Delaware residents and policy makers.
